

RESOLUTION NO. 2008 - 032

PROPOSING A REPLACEMENT AND DECREASE STREET LEVY AS SET OUT IN OHIO REVISED CODE SECTION 5705.19(G) TO BE SUBMITTED TO THE ELECTORS

WHEREAS, the amount of taxes which may be raised within the ten mill limitation will be insufficient to provide an adequate amount for the necessary requirements of the Village of Waynesville, Warren County, Ohio; and

WHEREAS, the present street levy will expire; and

WHEREAS, the Village Council wishes to replace and decrease the existing street levy at a new rate with a replacement levy for a five-year period of time effective with tax year 2008.

NOW, THEREFORE, BE IT RESOLVED by the Council of Village of Waynesville, Ohio, 7 members elected thereto concurring:

Section 1. That it is necessary to levy a tax in excess of the ten mill limitation for the benefit of the Village of Waynesville, Warren County, Ohio, to replace an existing levy.

Section 2. That said tax is for the purpose of providing for the general construction, reconstruction, resurfacing, and repair of streets, roads, and bridges, pursuant to Ohio Revised Code Section 5705.19(G).

Section 3. That this tax is to be at a rate not exceeding 1.00 mill for each one dollar of valuation, which amounts to \$0.10 for each one hundred dollars of valuation for five years commencing with tax year 2008. This tax is a decrease from an existing levy of 2.50 mills, equaling a decrease of 1.5 mills.


Section 4. That the question of the replacement and decrease tax levy shall be submitted to the electors of the Village of Waynesville at the general election at the usual places in said Village on the 4<sup>th</sup> day of November, 2008.


Section 5. That said levy be placed upon the tax lists commencing with the tax year 2008.

Section 6. That the Clerk of this Council be and she is hereby directed to certify copies of this Resolution to the Board of Elections, Warren County, Ohio, immediately after its passage and notify said Board of Elections to cause notice of questions of levying said tax to be given as required by law.

Section 7. That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
