

**RESOLUTION NO. 2009-015**

**A RESOLUTION STATING THE OHIO POLICE & FIRE PENSION FUND  
CONTRIBUTION PICK-UP FOR ELIGIBLE EMPLOYEES OF THE POLICE  
DEPARTMENT EXCLUDING THE CHIEF OF POLICE**

**WHEREAS**, the eligible employees of the Waynesville Police Department participate in the Ohio Police & Fire Pension Fund; and

**WHEREAS**, the Council for the Village of Waynesville has previously adopted a pick-up of none of the ten percent (10%) mandatory contributions required to be paid under Section 742.31 of the Ohio Revised Code for eligible members of the Police Department, excluding the Chief of Police; and

**WHEREAS**, Ohio Police & Fire Pension Fund has adopted new procedures for reporting picked-up contributions in order to properly prepare 1099-R forms for its members ; and

**WHEREAS**, the Council for the Village of Waynesville wishes to reaffirm, and/or restate its prior resolution in order to continue the pick-up under the new procedures.

**NOW THEREFORE BE IT RESOLVED** by the Village Council of the Village of Waynesville, \_\_\_\_\_ members elected thereto concurring:

**Section 1.** That effective as of the earliest date allowed by law, the Council for the Village of Waynesville has determined to continue to pick-up 100% of the ten percent (10%) mandatory contributions by the eligible members of the Police Department, excluding the Chief of Police. This 100% of the ten percent (10%) mandatory contribution shall be paid by the eligible members of Police Department, excluding the Chief of Police, through salary reduction.

**Section 2.** That said picked up contributions will not be included in the gross income of the eligible members for tax reporting purposes, that is, for federal or state income tax withholding taxes, until distributed from the Ohio Police and Fire Pension Fund.

**Section 3.** That said picked up contributions will be included in the gross income of the eligible members, for employment tax purposes, as the contributions are made to the Ohio Police and Fire Pension Fund.

**Section 4.** That the eligible members shall not be entitled to any option of choosing to receive the contributed amounts directly instead of having them paid by the Village of Waynesville to the Ohio Police and Fire Pension Fund.

**Section 5.** That this Resolution shall be effective from and after the earliest period allowed by law.
