

ORDINANCE NO. 2009-042

AN ORDINANCE AMENDING THE BOND AND OFFENSE SCHEDULES FOR THE VILLAGE OF WAYNESVILLE, OHIO MAYOR'S COURT AND DECLARING AN EMERGENCY.

WHEREAS, Section 33.01 of the Village of Waynesville Codified Ordinances provides for a bond schedule and schedule of costs for the Magistrate's Court, which is also sometimes referred to the Mayor's Court; and

WHEREAS, due to changes in the state law, Council recommends an adjustment of the bond and offense schedules related to the Mayor's Court.

NOW, THEREFORE, BE IT ORDAINED BY THE VILLAGE COUNCIL OF THE VILLAGE OF WAYNESVILLE, _____ MEMBERS ELECTED THERETO CONCURRING THAT:

Section 1. The bond and offense schedules for Village of Waynesville Mayor's Court, as authorized by Section 33.01 of the Village of Waynesville Codified Ordinances, shall be amended as set forth on the attached Exhibit "A" which is incorporated into this Ordinance.

Section 2. This Resolution is necessary for the health, safety, and welfare of the Village of Waynesville and for the specific reason of complying with the Ohio Revised Code as adopted by the state legislature.
